The Tara Lynne Arnold Scholarship

Criteria:

- The student must attend or have attended Angola High School.
- The scholarship is open to a traditional student (high school graduating senior) or a non-traditional student (returning back after an absence from high school) or currently enrolled college (university) student.
- Students who have received the scholarship, if they maintain a B average or better, may reapply for the scholarship.
- The student may attend any institution of higher education, pursuing a bachelor's degree.
- The scholarship may be used for tuition, room and board, fees, supplies, or any other class-required expenses.
- The student must attach an essay and character reference as explained in the application.
- Although there is not a required course of study for the applicant, those indicating an interest in majoring in Psychology and/or Women's Study will be given a preference.

Selection committee:

- A family member will take an active role in the selection process and school presentation.
- Representative(s) of the Steuben County Community Foundation.

Miscellaneous:

- If the student fails to attend as planned, the college will be instructed to return the scholarship money to the Steuben County Community Foundation to be deposited in the Tara Lynne Arnold Scholarship Fund, or an alternate could be awarded the scholarship.
- Modifications to the criteria above can be made at the request of, and with the approval of the family of Tara Lynne Arnold family.
