In February of 2007, the Steuben County Community Foundation Board of Directors created the “Not Your Ordinary Education” Scholarship that will provide scholarship assistance to residents of Steuben County in a non-traditional way. This scholarship gives students an opportunity to apply for assistance and focuses on education opportunities that are not typically a four-year bachelor’s degree. For students that are considering vocational or trade school, a certificate program, apprenticeship, skills-building courses for work including computer instruction, a secondary language, etc. - this is the perfect opportunity.

## *The “Not Your Ordinary Education” Scholarship*

### **Requirements:**

- The student(s) must be a Steuben County resident

Seeking training through:

- Apprenticeship
- Vocational school
- Trade School
- Certificate programs
- Or any other non-traditional education program

### **Selection committee:**

- Representative(s) of the Steuben County Community Foundation

### **Miscellaneous:**

- The scholarship may be used for tuition, books, supplies, room & board, or other school-related expenses.
- If the student fails to attend as planned, the college will be instructed to return the scholarship money to the Steuben County Community Foundation to be deposited in the “Not Your Ordinary Education” Scholarship Fund, or an alternate could be awarded the scholarship.

*NOTE: Modifications to the criteria above can be made at the request of, and with the approval of the Steuben County Community Foundation Board.*
